

# **ACCIDENT WAIVER & RELEASE OF LIABILITY**

For Scotland's Scream Park / Zombie Infection Ltd

PLEASE READ CAREFULLY – THIS IS A LEGAL DOCUMENT

## **1. Assumption of Risk**

I understand that this attraction is a full-contact, fully immersive Halloween experience which may include: darkness, loud noises, strobe lighting, fog, sudden scares, uneven ground, confined spaces, physical contact from performers, graphic horror effects, and simulated gore. I accept that these elements carry risks of physical or psychological injury. I voluntarily assume all such risks.

## **2. Health & Fitness**

I confirm that I am physically and mentally fit to participate and have not been advised otherwise by a medical professional. This attraction is not suitable for guests who are pregnant, have heart conditions, epilepsy, anxiety disorders, claustrophobia, or any condition that may be triggered by immersive environments.

## **3. Release of Liability**

I hereby release and discharge Zombie Infection Ltd, Lochview Theme Park (Scotland) Ltd, and their directors, officers, staff, contractors, and volunteers from any and all liability for death, disability, personal injury, property damage, theft, or other loss that may arise from participation in this event, except where caused by negligence.

## **4. Indemnity**

I agree not to bring any claim against the above parties and to indemnify them against any liability arising from my participation.

## **5. Conduct**

I agree to follow all event rules and instructions. I understand that aggressive or inappropriate behaviour, use of alcohol or drugs, or touching of performers/props will result in immediate removal without refund.

## **6. Medical Treatment**

I consent to receive medical treatment deemed necessary in the event of injury, accident, or illness during the activity.

## **7. Photography & Recording**

I acknowledge that the event may be filmed or photographed and consent to my image being used for promotional purposes.

## **8. Legal Jurisdiction**

This agreement is governed by the laws of Scotland, and any disputes will be subject to the exclusive jurisdiction of the Scottish courts.
